Trailing cables to be secured using anti-trip materials. Suitable marking tape will be used to assist entry to and from stage and to highlight step edges.	
Hazard 2 Manual handling	2	Musicians and crew	Refer to HSE manual handling publication and The Manual Handling Operations Regulations 1992.	People must seek assistance if a load is considered to be heavy. Please note the law does not identify a maximum weight limit. Consider using a lifting aid. Check route is clear of obstructions and hazards.	
Hazard 3 Working in low light	1	Musicians	Orchestral music stand light will be available if necessary.	Each music stand could be fitted with a light. The lights will be equipped with a suitable low-level light bulb.	
Hazard 4 Electric shock	3	Musicians and crew	Installed electrics will be fit for purpose and checked by the venue owners.	All electrical equipment will be fit for purpose. PAT tests and/or Electrical Maintenance Log will be in place.	
Hazard 5 Fire/Bomb/Terrorist threat	1	Musicians, crew & members of the public	Bandstand PA System. Venue entrance and exits.	Report any suspicious packages/audience members.	

Hazard 6 Hearing damage	2	Musicians, crew & members of the public	Band leader to monitor sound levels	Disposable ear plugs will be made available for the performers. The musicians will be strategically seated to avoid direct noise. A decibel meter will be used to monitor the noise levels.
Hazard 7 Outdoor weather performances	1	Musicians & crew	All performers and crew will be advised on suitable clothing according to the weather conditions. Performers will wear appropriate uniform.	During hot weather, all persons must apply sun screen at regular intervals. To avoid dehydration, bottled water will be available before, during and after the performance. The platform will be undercover and shaded. During cold weather, performers and crew will be asked to wear appropriate clothing. Flasks of hot drinks will be supplied. In both types of weather, the tour coach can be used for shelter and rest. If both types of weather are extreme, the event will be cancelled.
Hazard 8 Public areas	1	Musicians, crew & members of the public	All musical equipment will be kept on the performance area, only performers will be allowed access onto the platform. All cases will be stored away from the public right of way.	Band members will be on hand should the public ask any questions and/or request access to the platform.
